Chair Updates

Chair Hardiman provided comments regarding the board meetings. He stated that as the Chair, his job is to make sure that the board meetings are being conducted as efficiently as possible, ensure that the Commissioners are working together to conduct RRHA business and to provide oversight to help facilitate the work that staff is doing.

He shared the following recommendations on how he would like for the board meetings to be conducted:

- o The committee meetings should become the real workspaces for the organization so that when the information is presented at the full board meeting for approval, the Commissioners can vote and move these items forward with minimal discussion.
- Commissioners should attend the monthly committee meetings that they have been assigned to so that a quorum of the committee can be established. This will allow official action to be taken during the meeting, if needed.
- Commissioners who have not been assigned to serve on a particular committee should try to attend all of the monthly committee meetings.
- He discussed using a consent agenda during the board meeting so that those items
 that have been voted on and approved by the Committee can be listed first on the
 board agenda and voted on in a block at the beginning of the board meeting.
- O During the committee updates at the board meeting, staff should provide abbreviated updates that captures action items from their committee meeting. If a committee does not have any new item(s) to report on from their meeting, their report can be removed during the meeting.

Lease Enforcement Update:

Senior Vice President of Affordable Housing Kenyatta Green provided the following update on RRHA's Lease Enforcement efforts.

 400 East Grace Street:

WHEREAS, the independent audit for the year-ended September 30, 2021, resulted in a modified audit opinion. This is the result of not fully implementing GASB 68 due to the Virginia Retirement System not providing the required actuarial data through September 30, 2021.
